Information for Members

- It is compulsory for members with boats moored in the club arm to give a minimum of 24 hours service per year (see moorings conditions). A fee will be charged of £450 on top of your moorings if the 24 hours are not done.
- North Cheshire Cruising Club Limited does not allow residential mooring in the arm.
- Members who moor in the arm, must pay the C&RT licence through the club.
- Mooring at Whiteley Green is for an **absolute maximum** of 4 days
- All moorings have electric points
- There are water points and an Elsan disposal on site.
- The decision of the Land and Water Space Director is final.
- Friday night social is from 7.30pm onwards
- The workshop is available for use by members and is subject to the rules available in the rule book.
- Mooring and hardstanding are available – please ask for more details.
- All guests on site must be accompanied by a club member.
- Parking on club property is for members only. Non members or guest wishing to park on club premises must seek the approval of the Water and Land Space Director
- The club sells gas, diesel, coal, kindling, logs, blacking. Prices are on the wall in the workshop and on our website
- Use of the slipway and boat sheds are available to all members. Prices are on the wall in the workshop and on our website.
- I understand that any information given on this application can and will be used by the directors to ensure that all applications comply and are in line with the articles of association and that such documents can be viewed at any time in the future by any North Cheshire Cruising Club Director.
